The Declaration was established by the "Council for the Promotion of Partnership Building for the Future", which consists of the Chairperson of Japan Federation of Economic Organizations, the Chairman of The Japan Chamber of Commerce and Industry, the President of the Japanese Trade Union Confederation and relevant ministers (Cabinet Office; Ministry of Economy, Ministry of Trade and Industry; Ministry of Health, Labor and Welfare; Ministry of Agriculture, Forestry and Fisheries; Ministry of Land, Infrastructure, Transport, and Tourism).

Moving forward, the SBS Group will actively engage in fair trade based on this Declaration, while further deepening mutual trust with its suppliers and aiming to maintain its good partner relationships.
