SBS Holdings, Inc.

Agreement to Acquire NSK Group's Logistics Business

— Strengthening the business competitiveness of NSK Logistics with the logistics know-how of the SBS Group

SBS Holdings, Inc. (Head Office: Shinjuku-ku, Tokyo; President and Representative Director: Masahiko Kamata; hereinafter "SBSHD") has agreed with NSK Ltd. (Head Office: Shinagawa-ku, Tokyo; President & CEO: Akitoshi Ichii; hereinafter "NSK") to acquire 66.61% of the shares of NSK Logistics Co., Ltd. (Head Office: Shinagawa-ku, Tokyo; President and Representative Director: Yoshitaka Yoneyama; hereinafter "NSK Logistics") held by NSK, and today entered into a share transfer agreement.

Following the necessary procedures, SBSHD aims to complete the share transfer within 2024. As a result, NSK Logistics will be transferred from a subsidiary of NSK to a subsidiary of SBSHD.

NSK Logistics was established in August 1999 as a wholly-owned subsidiary of NSK. As a logistics function company, NSK Logistics is engaged in the domestic business and import and export business areas of the NSK Group and has high skills and know-how in the fields of transportation, storage, cargo handling, packing, import/export business contracting, and other fields.

As an integrated logistics company, the SBS Group has positioned M&A as one of its key growth strategies as a means of expanding its business scale and business portfolio, as well as securing talented human resources, etc. In this case, NSK Logistics will place the highest priority on maintaining a good relationship with the NSK Group and its business partners, while creating a system to provide comprehensive logistics services with higher added value through the synergy effects of the SBS Group's shared infrastructure and know-how, and other means.

Masahiko Kamata, President and Representative Director of SBSHD and President of SBS Group, commented as follows: "I am very encouraged that NSK Logistics will join the SBS Group to solve the '2024 problem' (a problem in the logistics and transportation industry in Japan that arises from the imposition of a cap on driver working hours) which is a challenge for the entire logistics industry, and to maintain a sustainable logistics network. By bringing together the resources and know-how of the Group companies, we aim to accelerate the Group's growth and become a top-tier logistics provider by enabling us to reach a new customer base."

As with companies that have joined the SBS Group so far, the management team of NSK Logistics will remain in place even after the share acquisition, and we will continue to integrate them within the SBS Group while maintaining the continuity of business operations.
