## Notice Concerning Change of Name of Consolidated Subsidiary

TOKYO, June 23, 2025—SBS RICOH LOGISTICS SYSTEM CO., LTD. , one of our consolidated subsidiaries, has decided to change its trade name to SBS Nexthird Co., Ltd., effective January 1, 2026. Details are as follows. The matter is expected to be formally decided at a meeting of the Board of Directors and an extraordinary general meeting of shareholders to be held in November 2025.
