Notice Concerning Agreement on the Acquisition of Shares in Bridgestone Logistics, the Logistics Subsidiary of the Bridgestone Group

TOKYO, June 30, 2025 – SBS Holdings, Inc.(Head Office: Shinjuku-ku, Tokyo; President and Representative Director: Masahiko Kamata; hereinafter referred to as "SBSHD") has entered into a share transfer agreement today with Bridgestone Corporation (Head Office: Chuo-ku, Tokyo; Member of the Board, Global CEO and Representative Executive Officer: Shuichi Ishibashi; referred to as "Bridgestone") to acquire 66.6% of the shares in Bridgestone Logistics Co., Ltd. (Head Office: Kodaira-shi, Tokyo; President and Representative Director: Yoshihiro Miyoshi; hereinafter referred to as "Bridgestone Logistics"), which is currently held by Bridgestone.

Following the necessary procedures, the share acquisition is scheduled to be completed on October 1, 2025. Upon completion, Bridgestone Logistics will become a member of the SBS Group.

The SBS Group has continued to grow by leveraging the collective strengths of its group companies to solve a wide range of logistics-related challenges. Our Group regards M&A as a key growth strategy both for expanding business scale and service areas and for securing top-tier talent and resources.

Bridgestone Logistics has provided high-quality logistics services by leveraging not only the on-site expertise and technologies it has cultivated through tire logistics, but also the brand power and network capabilities gained as a member of the Bridgestone Group.

Through this share acquisition, Bridgestone Logistics will maintain strong relationships with the Bridgestone Group and its major partners, while our Group will share its infrastructure and expertise, pursue collaboration and synergies in logistics operations, and work to establish a framework for providing higher value-added, integrated logistics services.

Masahiko Kamata, President and Representative Director of SBS Holdings, Inc., commented: "We are pleased to welcome Bridgestone Logistics into the Group as a strong partner in fulfilling the SBS Group's mission of resolving urgent challenges in the logistics industry—such as driver shortages and rising costs—and maintaining a sustainable logistics network. The tire logistics sector is also seeing rising demand for joint delivery systems as part of efforts to improve load efficiency, address labor shortages, and reduce environmental impact.
